Craft & Yard Sale Information, Rules, Terms and Conditions:

- The Community Craft & Yard Sale is a rain or shine event, no refunds will be given.
- Town of Jamestown is a local government. Funds collected will offset the cost of providing equipment and public safety, sanitation, and recreation staff to work the event.
- Parking for Vendors, once unloaded, will be available behind Town Hall. Please park the farthest away possible to allow patrons to park closer to the event.
- No drugs or alcoholic beverages may be brought into the sale area or anywhere else on the premises.
- Smoking is prohibited.
- All children must be accompanied by an adult.
- Tables, chairs, and items used for display must be provided by Vendor.
- The event will be advertised in local businesses, area newspapers, web sites, social media, etc.
- Vendors must remain set up for the full term of the event.
- Vendors must remove all items at the end of the event.
- Citizens of Jamestown participating in the yard sale may place a temporary yard sale notice on their lot to help in advertising the sale, however, the notice must be removed promptly at the conclusion of the sale.
- **Event Venue:** The event will take place in a 1.5 acre public park located at 101 Guilford Rd., Jamestown, NC 27282.
- **Admission is free and open to the public.**

As a participant/Vendor you will be assigned a numbered space at Wrenn Miller Park approximately 10' x 20' in size. **A registration table will be located at the amphitheater to assign space numbers and register for the day.** Your space frontage will be along sidewalk and your space will be in a grassed or mulched area. You must confine your sale to the assigned space(s). If you arrive and need/want more yard sale spaces, you may purchase additional spaces for \$20 each (as available). You may unload items along Perry Rd. which is adjacent to the park. **Do not unload along Guilford Rd.** No vehicles will be allowed to drive on park property. If available, park staff will assist in moving your items to your space.

You may begin setting up between 6:00 am and 7:00 am. All items must be removed from the park by no later than one hour after the scheduled conclusion of the event. Tables, chairs, and items used for display must be provided by Vendor.

Retail merchandise will be permitted if disclosed to staff in Vendor's application. No personal or professional services may be solicited or sold at the event. Certain items are excluded from sale at the yard sale including cars, trucks, any engine powered wheeled conveyance, boats, snowmobiles, all weapons and firearms including, but not limited to, hunting equipment, bb guns, air rifles and knives; alcohol, paint, paint thinners, hazardous chemicals, food for immediate consumption (Guilford County Health Department regulations must be followed), or any other item which may be deemed inappropriate on public property. Town of Jamestown and its assigned personnel reserve the right to regulate, at its discretion, any item for sale deemed inappropriate.
