Development Clearance Certificate

Instructions: A Development Clearance Certificate is required for all development regulated by the Town of Jamestown Land Development Ordinance. This Certificate must be completely filled-out, signed by an authorized Town of Jamestown representative, and (when required) submitted to the Guilford County Planning & Development Department for the appropriate permit issuance before any work may commence on the project. Changes to the scope of work or plat plan must be re-reviewed by the Town of Jamestown and a new certificate issued. Depending on the permit type a plot plan or other supporting documentation may be required.
